- 1. The Host of Noc Kinowa Juwenalia UEK 2017 is:
- a.The committee of the Juwenalia UEK 2017, Rakowicka 27, 31-510 Cracow represented by Edyta Śladowska.

b.Independent Student Association Cracow University of Economics, Rakowicka 27, 31-510 Cracow, later referred to as the Host.

- c.On behalf of The Host for the appropriate event proceeding related to organising the Noc Kinowa Juwenalia UEK 2017 project are responsible as follows: The Coordinator Grażyna Tor and the selected members and supporters of Independent Student Association: Martyna Omielska, Klaudia Soja, Anna Toporek, Piotr Kowalik, Jakub Matoga, Oskar Tracz, later referred as Project Team.
- 2. The terms and conditions are addressed to all people who will be present at the campus of the Cracow University of Economics during the event. Everyone is obliged to follow the terms and conditions.
- 3. People staying at the Cracow University of Economics campus area are under the regulations of the rules of the object. Entry to the campus area results in acceptance of these regulations.
- 4. Entry for the event is free of charge.
- 5. It is forbidden to bring into the event area: food, beverages including alcoholic beverages bought outside the event area, containers made of hard material, weapons and dangerous materials which include: explosives, pyrotechnic materials, strongly corrosive substances, drugs, psychotropic substances and any other items which could endanger other people's safety in the event area.
- 6. Members of the guard staff are entitled to carry out a search on people on the entry point in order to eliminate possibility of bringing in objects disallowed in paragraph 5.
- 7. The access to the event is denied to people:
- a. underaged
- b. under visible influence of alcohol, drugs and other similar substances.
- c. acting aggressively, provocative or in another way posting a threat to safety or public order,
- d. possessing objects disclosed in paragraph 5

- 8. Event participant is obliged to: listen to commands of the guard service and hosts, not to disrupt public order, follow the mentioned regulations and not to endanger other event participants safety.
