

CUE JUWENALIA 2019  
TERMS AND CONDITIONS OF THE NICEST CONTEST

1. The Host of The Nicest Contest 2019 is:
  - a. The committee of CUE Juwenalia 2019, Rakowicka 27, 31-510 Cracow represented by Aleksandrę Zanic,
  - b. Independent Students' Association of Cracow University of Economics, Rakowicka 27, 31-510 Cracow, later referred to as the Host,
  - c. On behalf of Host for the appropriate event proceeding related to organising The Nicest Contest 2018 are responsible as follows: Coordinator: Aleksandra Biadała and selected members and supporters of Erasmus Student Network Cracow University of Economics: Aleksandra Bajor, Bartłomiej Budziła, Przemysław Bury, Marta Marzec, Martyna Omielska, Paulina Zielińska, later referred as Project Team.
2. The club staff is responsible for the security of the club during the event, with the members of the security agency guarding the club.
3. The Access to the club is permitted for people of legal age or people who are 16 years old with legal guardians, after showing a ticket, with valid student ID depending on the ticket type, from 7:00 PM to 11:30 PM on the 7th of May 2019.
4. In case of lack of document entitling to a discount, additional payment is required.
5. After the exit from the event area the ticket becomes invalid.
6. Tickets return is not accepted.
7. People entering to the club area are obliged, on the request of club staff and organizers to show their ID or student ID.
8. All people entering the club should, upon the request of the club staff, go through a search of luggage, clothing in order to exclude bringing prohibited articles in the protected area.
9. Only members of staff of the club and the organizers are allowed to carry out a personal search.
10. It is forbidden to bring into the clubbing area: alcoholic beverages, weapons and dangerous materials which include: explosives, pyrotechnic materials, strongly corrosive substances, drugs, psychotropic substances and any other items which could endanger other people's safety in the event area.
11. It is prohibited to bring into and consume beverages and food products purchased outside of the club.
12. All people, who are damaging property, disturbing the event proceeding, creating a threat to human life or safety, not complying with the foregoing terms and conditions will be refrain from staying in the area where the event is taking place or withheld in aim to transfer to the Police.
13. The access to the area of the KWADRAT club will be denied to the people being under the influence of alcohol, drugs, acting aggressively, possessing forbidden objects listed in paragraph 7, not responding to cloth and bag search described in paragraphs 4 and 5.
14. People present in the club are obliged to obey the recommendations of the Project Team, volunteers and staff of the club, for the purpose of guaranteeing the security and order.
15. An access to a backstage room is reserved only for people authorised by the Host and the staff of the club.
16. The Project Team and staff of the club are entitled to not let people into the club and ask them to leave the club without stating the reason.
17. There are surveillance cameras in the club. Entrance is equivalent to consent to be filmed and photographed.

18. Taking part in the event means that the participant grants his permission for free using his public image for the documenting, advertising and marketing purposes by the Host.
19. The Host does not take any responsibility for any damages, injuries that came into being during the event.
20. The Host does not take responsibility for thefts happened during the event.
21. The right of interpretation and changes of this set of terms and conditions is reserved by the Host.
22. Entry to the KWADRAT club is equivalent to acceptance of this set of terms and conditions.
